### GOVERNOR SWIFT SUPPORTS FREEDOM'S WAY

Freedom's Way Heritage Association was pleased and honored to have received copies of a letter written by Governor Jane M. Swift to the Senate and Congressional Subcommittees in support of the legislation to establish a Freedom's Way National Heritage Area. She wrote: "I am well acquainted with the effort of the Freedom's Way Heritage Association's accomplishments in promoting the natural, historical and cultural resources prevalent in this particular region of the Commonwealth. These resources provide wonderful opportunities for recreation, environmental education and heritage preservation. A feasibility study, largely funded by the Commonwealth, highlighted these resources and provided representatives of the Freedom's Way Heritage Association the ability to share detailed information about their specific vision, goals and accomplishments.

"In addition to the preservation of these resources, heritage development will provide an economic spur to the region and the Commonwealth. Tourism in Massachusetts' third largest industry, and our depth of historical, cultural and recreational resources is a key reason visitors come to Massachusetts. Freedom's Way will play an important role as a vehicle for all Americans to connect with our shared heritage and sense of place."

A request for a similar letter has been made to New Hampshire Governor Jeanne Shaheen and we eagerly await her response.

## PRESIDENT'S REPORT

Dear Friends,

It is a new year for Freedom's Way Heritage Association. I am delighted to be able to work with you to continue the goals and objectives of the organization. I am personally extremely grateful to our members, friends and foundations for their support. With your help, the Association has come of age. Freedom's Way has weathered the trials of establishing a regional entity and suffered the growing pains of any organization that began as a handful of citizens with a dream.

Our dream has at times appeared illusive as we learned to negotiate the halls of government, and the demands of a political process without previous experience. Tremendous progress has occurred since we were incorporated in 1994. We have many more members, we have expanded the board, and we are organizing committees to give you more opportunity to participate. Please, take advantage of that opportunity and sign up to help.

With your past assistance, we have reached out into more communities and developed a library of materials for the educational efforts of local teachers and other community organizations.

We get closer to our goal of a federal designation each day. Massachusetts State Senator Pam Resor advised us earlier this spring that it is no longer a question of "if" we will receive a federal designation, but "when" it will be bestowed.

We are restructuring the organization in preparation for acquiring professional assistance. We need to be ready to function effectively as the Freedom's Way National Heritage Area when we receive that designation. It would be best to have an Executive Director already on board for when that occurs. To that end, we are seeking your support to help us find the right person and to have someone in place when the appropriation becomes a reality. With an Executive Director to provide expertise and assistance we will be better able to marshal the efforts of our volunteer board and committees. We should meet our needs with professionalism and pride.

I take for my person goals two main objectives for 2002-2003:

1. To structure FWHA to become a more effective board.
2. To achieve reasonable financial health.

I cannot do this alone – I need you to help me.

We had been told to expect Congress to schedule hearings about Freedom's Way in September of 2001. Naturally, the legislators had far more important issues to address in September. We await news of a hearing date. Keep your eyes and ears open!

## INQUIRIES ABOUT BECOMING PART OF FREEDOM'S WAY

Since the appearance of the Boston Globe Article on February 2, 2002 entitled: "42 Communities Unite in Heritage Area," by Alice Hinkle, about the proposed Freedom's Way National Heritage Area, seven communities have requested information. In each instance the inquiry included questions about how the towns were "chosen" to become part of the proposed area.

Freedom's Way Heritage Association was organized by a group of citizens who came together to discuss their mutual interest in preserving the most unique resources of the area. This grass roots organization reached out to neighbors and neighboring communities to form an organization of liaisons and members. It was this larger group that participated in the feasibility study conducted in 1997 and that was amended as a result of subsequent meetings until submission to the National Park Service in 2001. Those towns participating in the study defined themselves as outlined in the attached explanation and the geographic region was based upon that self-definition.

## THE GRASS ROOTS PROCESS THAT LED THE PROPOSAL OF A FREEDOM'S WAY NATIONAL HERITAGE AREA

The Freedom's Way National Heritage Area legislation (HR1027/S1925) process has been underway since 1997. Freedom's Way conducted an extensive Feasibility Study in order to demonstrate that the proposed legislation met the criteria for national designation. If this legislation is passed, the Freedom's Way National Heritage Area and the National Park Service must then conduct a 3-year Management Action Plan for approval by the Secretary of the Department of the Interior. Funding for a grant program might not be available until the Management Action Plan is accepted.

Towns named in the Freedom's Way National Heritage Area legislation participated in a Feasibility Study in 1997 and the development of an Addendum submitted to the National Park Service in 2001. The process that led to the completion of the study and addendum was an active grass-roots effort. Hundreds of town representatives and their local officials participated in a series of workshops. During the workshops the participants framed the themes that they considered exemplified their specific geographic area. The overall theme these participants selected for themselves is the New England Landscape. That theme was finally divided into subthemes:

- I. Rediscovering the Landscape of Democracy
- II. Inventing the New England Landscape
- III. Shaping the Landscape of Democracy

Critical to the development of these themes was the participants' desire to illustrate the importance of the landscape to the emergent conservation movement and the philosophies of the region's visionaries and experimenters

some of whom were: Benton MacKaye, Ralph Waldo Emerson, Henry David Thoreau, Bronson Alcott, and the Shakers. The uniqueness of this region stems from its attraction to generations of people who expressed their philosophies through an evolving understanding of man's connection to the landscape and the meanings of the evolutionary changes in the landscape wrought by man. While these visionaries wrote and thought about democracy, and experimented in democratic forms, they were also passionate about and experimented in land reform and usage. They viewed democracy as part of a larger concept. Thus, the defining themes listed above are intended to be interconnected. For example: Henry David Thoreau wrote about his discoveries within the native landscape and his concerns for preserving natural resources. He was also an experimenter in land use and plant reproduction. His interpretation of his environment led him to his views about humankind and his democratic principles.

These themes or stories will be told through participating institutions that have made known their interest in the themes and have agreed to develop related educational programs through regional partnerships.

The Freedom's Way National Heritage Legislation under consideration by Congress is fixed at 42 communities. Once designation occurs and an appropriation to conduct a Management Action Plan has been approved, the examination of boundary adjustments may occur.

We suggest, as the Freedom's Way Heritage Association did in 1997, that each town considering inclusion participate in a feasibility study. Data relating to the themes should be gathered. The feasibility study should include:

1. Inventory of Natural Resources, including Conservation Areas
2. Inventory of Cultural Resources
3. Inventory of Historical Resources, Sites, Buildings, etc.
4. Maps appropriate to the above lists
5. List of Municipal departments with names
6. List of local liaisons or contacts for each town
7. Names of ten influential citizens to participate in public forums
8. Letters of support from:
  - a. Municipal Officer/s
  - b. Planning Board
  - c. Conservation Commission
  - d. Historical Commission
  - e. Chamber of Commerce
  - f. Major Businesses
  - g. Interpretive Center with permission to use facilities
9. Series of public forums to obtain grass root support and to build consensus on appropriate FWNHA themes or develop new theme.
10. Develop a Funding Plan to increase state and federal appropriation.

Legislation to establish a Freedom's Way National Heritage Area has been filed in both the House and Senate.

*Bill # H.R. 1027 To Establish a Freedom's Way National Heritage Area in the Commonwealth of Massachusetts and the State of New Hampshire and for other purposes* was filed March 14, 2001 by sponsor, Congressman John W. Olver, and was co-sponsored by Congressmen Charles Bass, Edward J. Markey, James P. McGovern, Martin Meehan, and John F. Tierney. Congressman John Sununu has since signed on as a co-sponsor. *Bill # S. 1925 To Establish a Freedom's Way National Heritage Area in the Commonwealth of Massachusetts and the State of New Hampshire and for other purposes* was filed February 8, 2002 by sponsor, Senator John F. Kerry and was co-sponsored by Senators Judd Gregg, and Edward M. Kennedy. Senator Bob Smith supports our efforts. The bill has been referred to the Senate Committee on Resources. Passage of the current Freedom's Way National Heritage Area Act Bills will:

- *create the Freedom's Way National Heritage Area*
- *designate Freedom's Way Heritage Association, Inc. as the Management Entity*
- *specify roles, responsibilities, and authority*
- *authorize up to \$ 1,000,000 / year appropriation for 15 years with a limit of \$10,000,000*

As an organization, we have said that our primary purpose is theme development and education. As we strive to keep on target, we must ensure that we have sufficient funds to accomplish our mission and goals. Committees will meet at the convenience of committee members.

### Finance Committee. Chair, Mary Whitney

This committee develops financial strategy, plans and budgets. It also develops policies in regard to handling of funds, bookkeeping, financial data entry, insurance, etc. It will coordinate grant appeals, fundraising, operating grants, gifts, secure financial resources. Ways and Means or fundraising for local business and individuals.

### Governance Committee. Chair, Lucy Wallace

This committee reviews the organization's policy in re its Mission and Goals. It will recommend bylaw changes where necessary and establish a mechanism for addressing issues and position statements. The structure of the organization will be part of an ongoing agenda.

### Grants Committee. Chair, James Baecker

This committee will write the grants and prepare material for funding requests. It will also be the responsibility of this committee to develop the Executive Director job description and selection process for board approval.

### Facility Committee. Chair, Meg Delorier

When new office space is needed, the committee will find suitable space, and it will periodically review office requirements, sets goals for equipment purchases and upgrade, etc.

### Legislative Action Committee. Chair, Richard Canale

This committee will monitor legislative actions and calendars. It will regularly contact state and national legislators to seek progress reports, and coordinate the efforts of local people with legislators – arranges for constituent meetings.

### Membership/Liaisons. Co-Chairs Christine Bergeron and Michelle Ciccolo

Plans for membership drives and new members. Coordinates the activities of liaisons. Recommends new board members.

Liaisons: Community contact person acts as a conduit of information between the town and the Association.

### Public Relations Committee. Chair, Open

Responsible for outreach program. Develops and coordinates a Speakers Bureau. Coordinates TV or Radio interviews, newsletters, press releases and web page updates.

### Theme Development Committee. Chair, Milly Chandler

Development of theme related Projects and Activities. Oversees the execution of approved projects: theme development, curriculum development. Site selections, theme and sub-theme development, subjects, town data, research, library, consultants, and studies.

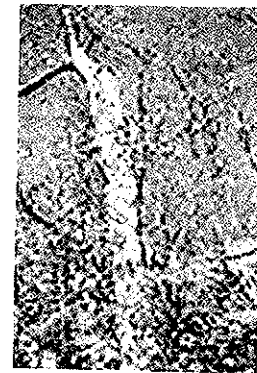
